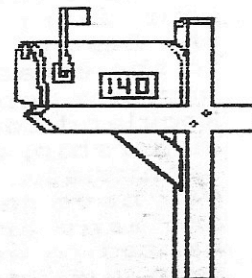

PRESERVATION OF COUNTY RECORDS PLANNED...

A Feb. 8, 1989 article in the "Journal News" quotes then acting County Clerk Joyce Altieri regarding the restoration of NY State Census records from 1855-1925. (Ms. Altieri is a former speaker at GSRC)

The original handwritten documents that are as old as 130 years have become brittle and subject to deterioration and cracking. To restore them, each sheet must be inserted into a Mylar envelope after pages are mended and corners reinforced.

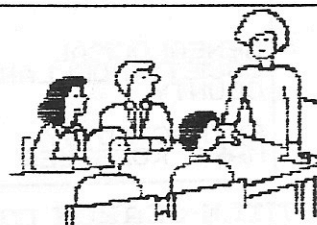
The records, now contained in 10 bound volumes, will be restored by Brown's River Bindery in Essex, VT at a cost of about \$13,000. When the restoration and protection process is finished in about eight weeks, the records will be contained in 17 bound volumes of uniform thickness and size.

"I feel we are preserving a bit of history," Altieri said. "Restoring these precious books will ensure their availability for generations to come."

HOW TO DO A TITLE SEARCH
PRESENTED BY VINCENT SARRO, OF
HUDSON VALLEY ABSTRACT COMPANY,
JUNE 23, 1988

In the title insurance business, title examiners look at records in the County Clerk's office, the Surrogate Court, and the Treasurer's office. There are also old maps and tax list going back to 1890 in the Sain building. The system used in Rockland County before 1980 was the Grantor/Grantee system, or the person who grants the deed and the person who receives the deed.

Theoretically, one can trace a piece of land back to the original patent from the King of England, although land descriptions at that time were not very accurate. Guidelines require title examiners go back 40 years. Many Rockland County records prior to 1793, when Rockland County was established, are up in Goshen. However, in the Rockland County Clerk's office, there are 3 old books 2 for deeds and 1 for mortgages. If one knows where his/her ancestor lived, then information may be found in these books.

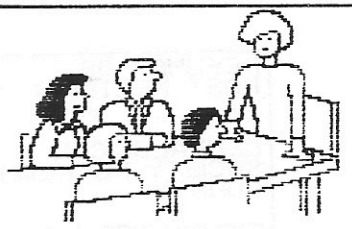
One can look up in the Grantee Book the name of the person who owns it now. Then take the change of title back. However, it is difficult to get behind a deed when a person inherited the property. If one reads some comments made in the current deed, they may be common to an old deed of that property. However, records weren't as accurate back then. Older descriptions of land were very vague; i.e. chains, links, "old oak tree," etc.

Another place where records (wills, letters of administration, etc.) are kept is the Surrogate Court. Title passes through death and wills. The Clerk's Office also has the old State Census records up to 1925. There are old tax lists, some going back to 1890 and voting records in the Sain building. (cont.)

TITLE SEARCH CONT.

The Town Assessor makes the tax roll. Every September and January he sends out the tax bills. When the bills are not paid, the County comes in and pays the delinquent bills, and then tries to collect them from individuals.

Mr. Sarro noted that the workers in the County Clerk's office are very friendly except that they really don't know their way around. If assistance is needed, one might be better off asking a title examiner who may be working there at the time.

On rare occasions, title examiners use court records. If they are stuck, they will use mortgages.

Regarding a title examiner's background, Mr. Sarro stated that there are very few courses offered in this field. One course for title examiners is offered at NYU. The training takes so long, one really has to know someone to get into the field. This type of work used to be done by lawyers.

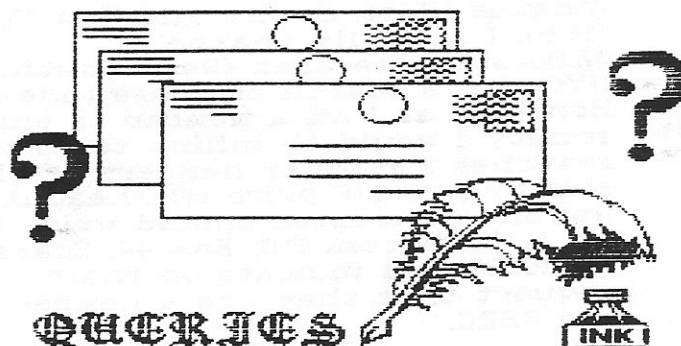
Concerning unrecorded deeds, Mr. Sarro gave the following example: In 1900 your grandfather willed a piece of land to your father; he died, and you attempt to sell the property. If the deed is presented to the title examiner at that time, it can be recorded then.

Unrecorded deeds occurred many times from the time the original patents were cut up and boundaries were not precise, but it wouldn't happen today because there is a lawyer involved, and it is his responsibility to see that the deeds are recorded.

Mr. Sarro stated that there are some interesting maps of the old railroad rights of way because they came through people's properties and the family names are on the maps. These are located in the County garage. He

He said that he personally has a few unrecorded maps; i.e., of Stony Point from the 1930's done by U.S. Gypsum around Grassy Point.

He offered assistance, within the confines of his schedule, to anyone in our group.

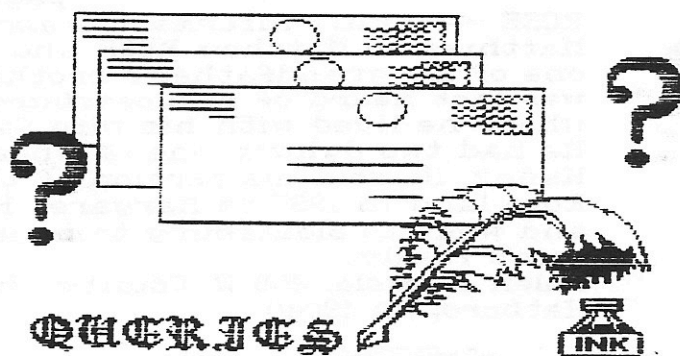

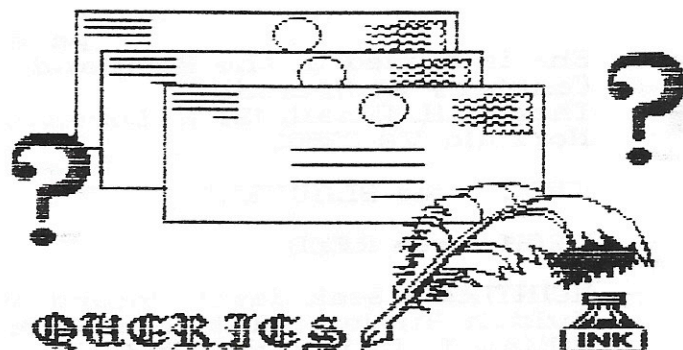
