### **Friends of Doodletown**

Friends of Doodletown is a 501(c)(3) public charity devoted to preserving the history of Doodletown and other vanished hamlets of the Lower Hudson Valley of New York State. Many of these places were condemned by the Palisades Interstate Park Commission in an attempt to balance the ever-increasing demand for recreation and wildlife enjoyment with limited land space.

These hamlets were removed over several decades from the early 1900s to the mid 1960s. Their populations were displaced and forced to live elsewhere. The fates of the hamlets themselves, however, were varied. Some were flooded by artificial lakes. Others were torn down and developments sprang up over or around them. Still others, like Doodletown, had their structures razed but nothing more was ever done to the town. This last fate resulted in a collection of walls, streets, steps, and stone foundations still visible to this day.

Friends of Doodletown is desperately trying to preserve these hamlets' histories and physical remains before they are gone forever. In this sense, we have amassed a collection of reports, pictures, and personal recollections from the hamlet's denizens as to what life was like before the Park. For those towns that were not flooded, we are also actively working to discover and preserve what remains of their physical structures. Donations to support our preservation efforts or volunteers to participate in our annual clean-ups are always welcome, since we are a small group (only 4 people) and are grateful for the assistance. We also encourage the towns' former denizens, their descendants, and fellow history buffs to contact us with any memories, photos, or reports they may have. Time has a way of erasing both memories and physical structures and we truly appreciate any help in preserving both!

**Research Recommendations: *Historical Markers Database*  
by Michael J. Leclerc**

As genealogists we know the importance of studying history. An understanding of a location's history is critical to researching ancestors' lives. Many of our ancestors participated in major historical events. Many of these events have been commemorated with markers placed by historical societies as well as by local, state, and federal governments, and other organizations.

The Historical Marker Database attempts to document these markers. Each marker has its own page, and includes a photograph of the marker; a transcription of the words on the marker; date and by whom the marker was erected; the marker's location, including latitude and longitude; other markers in the area; cross references to related markers; and a Credits section for information on the individual who submitted the marker. Anyone is free to add markers within certain guidelines. Users can also add information to existing marker pages.

Markers are grouped by categories, such as Abolition and the Underground Railroad; Arts, Letters, and Music; Charity and Public Work; Entertainment; Hispanic Americans; Labor Unions; Military; Patriots and Patriotism, etc. There are also Marker Series, such as those for the Ohio and Erie Canal; Battlefield Markers Association; Bergen County, New Jersey, Historical Society; National Historic Landmarks; The Historic National Road, and the St. Augustine, Florida, Freedom Trail, among others. In addition to the United States, there are markers from Canada, Czech Republic, France, Germany, Ireland, Netherlands Antilles, and the United Kingdom.

In addition to the markers on this site, there are a number of links to other websites with historical markers. As I looked around the Historical Markers Database, I saw markers commemorating the following:

- First Performance of Handel's Messiah (Leinster, County Dublin, Ireland)
- First Successful Cotton Mill in America (Pawtucket, Rhode Island)
- Birthplace of Insulin (London, Ontario, Canada)
- Edward Wightman Memorial Marker (Litchfield, Staffordshire, England) [the last person in England to be burned at the stake for heresy]
- "Old Ironsides" in Dry Dock 1 (Charlestown Navy Yard, Boston, Massachusetts)

The publisher of the site is J.J. Prats of Springfield, Virginia. With the assistance of a number of editors, he keeps the site up and running and free to all. This website is a great place to find historical markers that might commemorate your ancestors, or events in which they participated. You can search the database, or find out more about contributing to it, at [www.hmdb.org](http://www.hmdb.org). Many thanks to Jack MacKeen for telling me about this site.

“Naturalization – the path our ancestors took to become citizens.”

Presented by Joseph Lieby, genealogist

### HOW DID AN ANCESTOR BECOME A CITIZEN?

Papers will often tell where they came from and information about them. Not all immigrants became citizens. Some stayed and worked for a time, and then returned to their homeland.

Some families remained self-contained within their own national group, speaking their own language and keeping their own customs.

Some became citizens in order to vote, and in the 19th century when western lands were opened, as a citizen they were able to receive land and move west.

Some became citizens to make a new life for themselves. Preceding wartime, it was desirable not to be an alien in a country at war.

Before leaving the homeland, a letter of Denization could be applied for requesting permission of the Crown to own land in the new country.

The process to become a citizen has changed many times during the life of this country.

Generally, a Declaration of Intention was filed in any court that kept records. This paper contained a physical description of the person applying, where they were born and other personal data. In some states in order to vote, it was enough that a person had filed their first papers but not the final ones.

After a period of time, final papers could be filed and the person became a citizen of the United States of America.

Homestead Laws had been established to obtain land in the west - a person had to have filed first papers.

#### HOW TO BECOME A CITIZEN:

Naturally: A person born in the United States is automatically a citizen.

Derivation: If an immigrant parent became a citizen, a minor child or children would be citizens.

Legislation: At times states have naturalized an entire group of people. In 1866, there was the Civil Rights Act; in 1868, the 14<sup>th</sup> Amendment

Up to 1922, if a man became a citizen, his wife automatically became a citizen.

In 1907, if a woman married a non-American, she lost her American citizenship.

#### QUERIES

Member Heidi Eggebroten has written us a lengthy letter, which asks for help in obtaining information about her great-grandfather who went West from this area. I have abstracted her information below and urge members having information to respond.

" ... The McHenry Co, IL history states that Thomas Masters Cook ran away from an abusive caregiver as a young man. I have since found that he was born to Daniel and Elizabeth Van Houten Cook, who married Aug 20, 1828, in the "Dutch" Church. The birthdate of 1795, in New Jersey may be incorrect as may be her father's name of Peter Van Houten. Daniel is supported (sic) to have been born 1793, is father John H. Cook?

Thomas Masters Cook's wife, (my gg grandmother) Sarah Jane Coquillette (b. 11 May 1821) is also on Rockland lines: Sarah's father William Coquillette (b. 31 Jan 1792, d. 31 May 1835 in Rockland) of Daniel & Maria Stevens Coquillette; Daniel Coquillette & Mary Aeratie; Francois Coquillette & Silvie Sicard.

Sarah Jane Coquillette's mother was Maria Garrison of Joseph & Brehje Vanderbilt Garrison. I know no more about the Garrison line than Joseph's parents Gerret Gerretse & Aetje Seaman.

Maria Josephse Garrison's, mother (b. 1 Mar 1796, Rockland) Brehje Vanderbilt (b. 1765) was the daughter of Jacobus (b. 15 July 1731) & Brehje Tallman (27 May 1739) Vanderbilt.

Jacob Vanderbilt's parents may have been Jacobus Vanderbilt (b. 1694) & Hillietje Hardenbergh.

Brehje Tallman's (b. 27 May 1739) parents may be Douwe & Bechtie Haring Tallman.

I would like to know who Thomas Masters Cook was under the care of when he ran away, and since he married Sarah in Rockland, if they were old family friends, how and when did his parents die, were they "patriots," & any thing else I can learn about him. ...."

I have also re-arranged her information into Ancestor Table format, to put the data in familiar form, with additions from my records, and ask others to provide Heide with additional information.

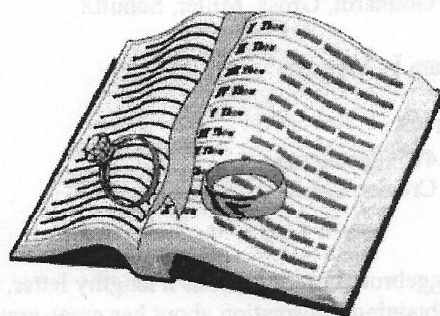

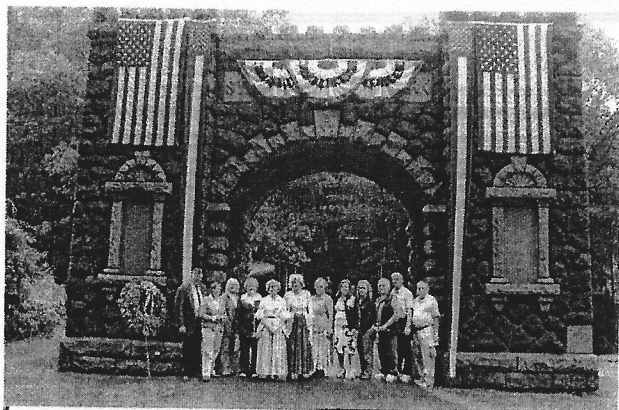

"Arch Resplendent" The Stony Point Memorial Arch is graced with flags, bunting and a wreath for it's re-dedication ceremony, and in turns shelters it's patrons, members of the Shatemuc Chapter of the Daughters of the American Revolution and their guests.

The 100-year -old Stony Point memorial arch was rededicated last weekend in a ceremony attended by hundreds that was also a significant element in Rockland County's participation in the statewide Quadricentennial celebration of the Hudson-Fulton-Champlain birthday party.

The arch, at the entrance to the historic Stony Point Battlefield state historic sight off Route 9W in the county's northernmost township, was initially constructed and dedicated in 1909, when the and the state celebrated the Hudson-Fulton Tricentennial event.

The battlefield site is 33 acres of hilltop land on a small peninsula overlooking the Hudson River. It is where the American and British forces fought several times during the American Revolutionary War, as both sides tried desperately to gain control of the Hudson River Valley, and prevent the other side from being able to use, navigate or cross it.

Whoever controlled the Hudson controlled the outcome of the war; the theory went, because it divided the New England colonies from the central and southern colonies, splitting America into two nations.

Ultimately, of course, the American patriots won in 1783, and the United States has been an undivided nation ever since , with the exception of the Civil War nearly a century later.

Shortly after the turn of the 20- century, the Palisades Interstate Park Commission was formed about 1901 to protect the land along the river's western shoreline from destructive rock quarrying that threatened the very existence of the prominent Palisades.

The first big bit of historic conservation ever undertaken in Rockland County was the acquisition of the Stony Point Reservation by the legislature of the state of New York, historian LeRoy Kimball told the Rockland Conservation Committee in 1940, at a meeting appropriately held in the Stony Point Battlefield Museum.

Kimbal had been actively involved in that acquisition 31 years earlier, and was later an active participant in constructing the stone museum building and outfitting it with exceptional collection of artifacts and publications relating to the Revolutionary War in this area. He also paid tribute to the Daughters of the Revolution, a hereditary and genealogical group active at the time, for their active participation in the acquisition and preservation of the site, and the construction of the arch, which was their personal contribution.

The group is now long defunct but another group has been created in it's stead, the Daughters of the American Revolution, or DAR, which has the same goals.

It has picked up the pieces left by the earlier counterpart, and was the mainstay in staging last week's Quadricentennial celebration and re-dedication of the arch, which they have adopted. Rockland County DAR Regent Martha Erickson of Monsey said both the chapter and state organizations now assume responsibility for the arch, and will maintain it in the future.

The local group is the Shatemuc Chapter, and its goals are patriotism, education, and historic preservation, Mrs. Erickson said....

Assisting the DAR throughout Saturday's event were members of the Stony Point Chapter of the Sons of the American Revolution, and staff members from the Stony Point Battlefield state historic site.
