GSRC Members at the Rockland County Archives And Records Center, Building S, Pomona, NY

In response to a program by Peter Scheibner, Rockland County Archivist, at the GSRC meeting of 24 Feb 1998, six members volunteered to give at least a half-day each to help sort and catalogue records. When the Archives opened in October of 1998, the six members were there to begin work.

Currently, there are eight members: Florence Anderson, Joan Brooks, Marie Koestler, Margaret McCollough, Richard Peterson, Henry Rennie, Susan Schwinn, Curtis Shuart and Maryann Smith. During the twelve months of 2009, they have logged a total of 2,605+ hours!

The group has worked on court records, deeds, marriage records, wills, etc. For public use there is a computer kiosk where many of the records stored at the Archives are indexed and available for viewing. Other records include naturalizations, census records, tax rolls, and maps.

Besides volunteering 4 hours a day, two days a week. Marie, Florence and Richard proofread the cemetery, funeral home and census records that Les Baisley, Marie Koestler and Joan Brooks prepare. Marie, Joan, Maryann and Margaret have traveled to Albany to record the birth, death and marriage records that have appeared in the newsletter.

Maryann is currently working on recording Oak Hill and Rockland Cemetery records.

Marie is proofing the Tappan Baptisms that Mr Leith has prepared and entering St Paul's Church records.

Margaret is working on a Korean War project of those who served from Rockland County.

Joan is entering church records and the 1925 Census corrections.

Henry is working on the records of the Middletown Baptist Church in Nanuet, N.Y.

Susan Schwinn assists researchers finding information on the Kiosk, census records and answers some correspondence for the Archivist.

Helpful Hints

Recently I was asked to get copies of 3 wills at Orange County Surrogate Court in Goshen NY.

The requestor included name, liber and page for each will. She had gotten them from the Sampubco list of available wills. Fortunately, she included the years of death for each, because when I went to surrogate court, the names for those libers and pages were correct...but the years of death were way off. If I had copied the ones cited all 3 would have been for the wrong people.

So I spent 2 hours at surrogate court, creating an index (see below) showing which years are included for each liber from 1787 to 1900, by checking date of probate for the first and last entries for each liber.

Re: "Early Orange County Wills (1731-1830)"-it was created by humans, and I found one will that was missed by this book. OCGS has another book covering probate records of the same era, if you care to stop by and take a look at it. In general, though, if no will for an individual was listed in that book, the odds are very high that it doesn't exist...

PLEASE NOTE: - The accuracy of information presented in Ancestor Tables is the responsibility of the submitters, and not the responsibility of the Genealogical Society of Rockland County. Please do not submit information that is not documented. If there is any uncertainty, the information should be marked with a "?." Anyone who desires further information, documentation, or has questions or additional information, should contact the submitter at his address given at the head of the Table.

Additional data should be sent to the submitter, and copied to the Ancestor Table Editor, at the address noted above. We will publish comments and corrections, etc., in the Ancestor Table Forum.

The numbering system used is as follows: The first person on the list is number 1. Each ancestor's father is Twice that person's number. Each wife is one number higher than her husband. If all ancestor's were known, then all numbers would be used. When an ancestor is unknown, the number is skipped. The number in parentheses after each generation is the number of ancestors in that generation. A ♦ indicates the last known ancestor in that line. A * indicates that the individual occurs more than once in the ancestry, ** indicates the second listing for the individual.

NEW JERSEY SURROGATE RECORDS.

Each of the 21 NJ counties has a Surrogate's Office:

Copies of Recorded Wills, 1804-present. The original wills from 1670 to 1999 were filed with the state and may be found:

1670 through 1952: NJ State Archives.

1853 through 1999: Superior Court of NJ.

2000 through present: original wills are filed with the individual Surrogate's Offices.

Estate files, 1700s-present: dates vary by county, some date back to the 1750s.

Often contain administrative records not covered in the will. Important when a person died intestate.

Adoptions: Records prior to 1940 are open to the public.

ACCESS TO RECORDS:

Most records are open to the public at the Surrogate offices

Check: "Indexes to Estates." Indexes have been microfilmed by the church of Latter-Day Saints (LDS) (except Morris Co.) and are available at the NJ State Archives or through inter-library loan via your local LDS Family History Center:
