

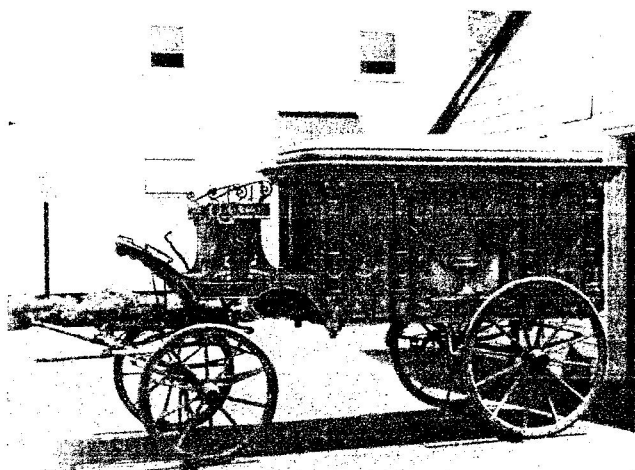

I'm often asked by people why should I be interested in genealogy? America is a mosaic of the rich and poor, the young and the old, from every kind of national, ethnic and religious back-ground. When my sister was suffering from leukemia I turned out to be a perfect DNA match for a stem cell transplant. Spending time with her was an unforgettable joy. Although she never went into remission, and was unable to receive my stem cells, a medical profile of a patient's ancestor's sickness is a vital reference tool for physicians in diagnosing and treating illnesses.

History can be sort of an anchor. The uncertainties of the present day can pale in comparison to what your ancestors may have suffered. By studying the past and learning how your ancestors coped with economic uncertainty, war, depression, poverty and sickness you can gain strength for your own journey in life. The Rockland County Genealogical Society Board of Trustees and its members are here to help you do your own digging. Our web site alone contains over 40,000 pages of genealogical information. We have talented genealogists ready to assist you in your search for family roots or to guide you to the vast resources and networking via the Internet that RCGS possesses.

This is an exciting time for the RCGS. We are trying to find a home for the accumulated records, and archival material that I uncovered dating back to 1832 in an old barn at the Historical Society. The Orphan Train Era (1854-1929) was the largest mass migration of children in American history. Over a 75 year period more than 400,000 children were transported by rail across America.

Digging for lost ancestors takes you to strange places and in the course of your excavations you learn about history, geography, psychology, and law. It is not the study of dry bones. You will become fascinated by the times in which your ancestors lived. You may even find you're related to a prominent historical figure. That talent you possess may have been passed down to you by your ancestors.

Genealogy doesn't call for a lot of expensive equipment-just a notebook, a few pencils, an inquisitive mind and a willingness to ask questions and dig for facts. GSRC Program September 28, 2010
ORPHAN TRAINS PRESENTED BY TOM RILEY
1854-1929

By means of a talk and a prepared Video, Tom Riley told the audience about the Orphan Trains. He first explained when and how he became interested in the subject. While researching material for his book on "Happy Valley,: A History and Remembrance," he discovered the records of the Orphan Train riders from 1832 through 1929 had been stored at Happy Valley; later transferred to The Historical Society of Rockland County, New City. Tom was able to go through all the boxes in the barn at the Society and learned of the wealth of little known information about the trains that carried destitute children from New York City to new homes in rural America.

In 1832 a group of women who were involved in temperance societies were appalled at the conditions in which 10 to 15,000 homeless or destitute children in New York City were living. They formed the American Female Guardian Society. Their mission was to help the young girls in the Five Points area of Manhattan who were orphaned and turning to prostitution, thievery and alcoholism. The group soon added boys to their care. They also gave care to alcoholic men who would sign pledges to abstain from alcohol.

New York City in the 19th century was a magnet to immigrants and the poor in search of jobs, a haven for gamblers, thieves and murderers. Adults fell victim to alcoholism, prostitution, drug addition, loss of jobs, evictions, disease and deaths – leaving their young children to cope with living on their own. At any one time these 10-15,000 orphans were living on the city streets. Jacob Reis, photographer, recorded their images for posterity.

Charles Loring Brace, a Connecticut Minister resolved to save the children from their misery. In 1854, he founded the Children's Aid Society. He felt these children must be removed from the city to the rural areas of America. Rev. Brace and the American Female Guardian Society worked together to solve the problem. It was decided the best way to send the children to their new home would be by train, and the "Orphan Train" era began. The group advertised in the "Advocate" for families wanting to help a child or two. By signing a pledge form and sending in \$1.50 to AFGS, they would promise to be at the railroad station when their child arrived from NYC or some other city. They could specify whether they wanted a boy or girl, etc. This movement went on for 75 years and ended in 1929 when new ideas came about as to the best manner in which to care for these homeless children.

The video portion of the program was extremely moving – seeing these hundreds of homeless destitute children roaming the city streets; begging, borrowing or stealing food; in ragged or mismatched clothing; sleeping on the streets, in alleyways or wherever they could find a "safe" spot. Then the trains came with their loads of children who were being shipped across the country to new homes. Parts of the video showed children who had grown up and were now into their senior years and had made a success of their lives. Some had found good homes and while others were not so fortunate; still they made the best they could of their uprooted lives.

Tom's ambition is to have Rockland County open an Orphan Train Museum in which to store the records of this unfortunate era. NYC is not interested in the subject – the politicians seem to feel it was not a city problem at that time or now, and that it was something the children's aid societies and others were handling. From the Historical Society, the records had been sent to Springdale, Arkansas, where one woman began work on cataloging them; later Concordia, Kansas, opened a museum and wanted the records. The museum has offered to return the records to New York if and when a museum was opened in the state.

MAINE VITAL RECORDS RESTRICTIONS & FEES - 12 Jul 2010: Individuals requesting copies of vital records filed less than 100 years ago must provide documentation establishing their right to the documents. Positive identification – driver's license, passport, or other government-issued picture ID. Genealogists and researchers with researcher ID card re granted access. For records more than 100 years old there are no restrictions.

ANCESTRY.COM TO ACQUIRE SWEDEN'S GENLINE.SE This website joins Ancestry's family of nine web properties globally. Genline.se has over 5 billion historical records and 17 million family trees; 26 million digitized Swedish church records spanning more than 400 years from the 16th to the 20th century.

ROSALIE FELLOWS BAILEY elected to the National Genealogy Hall of Fame. Ms. Bailey was a leading authority on the history & records of the early families of New York City & the lower Hudson River Valley. She was born on 07 August 1908 in Oak Bluffs, MA. She died in NYC on 06 Jun 1991. Her *Pre-Revolutionary Dutch Houses & Families in Northern New Jersey and Southern New York* (a classic) was written when she was 28y. Two other works are *Dutch Systems in Family Naming & Guide to Genealogical & Biographical Sources for NYC*. In 1941, at the age of 33y, she was the first woman elected as a Fellow of the American Society of Genealogists. Among her other writings and other positions, she served as secretary to NY G&B from 1953 to 1957.

CHANCERY COURT FILES. Court papers with their red ribbons may be the answer to your brick wall! Chancery Court (Equity Court) hears equity cases – they are based upon fairness of an issue rather than upon law. Case files are usually indexed by the last name of the plaintiff. Sometimes a second alphabetical list by the defendant's surname is available. In an equity versus law case, the prevailing party at law receives a monetary award of damages determined by a jury. In an equity case, the judge or chancellor determines both the facts and the appropriate fee.

CONFEDERATE DEATH & BURIAL RECORDS The Confederate War Department attempted to maintain various death records. When reconciliation between the North & the South came about decades later, it was agreed to render an accurate accounting of the "forgotten" Confederate dead. The compiled military service records (CMSRs) of Confederate volunteer soldiers offer the most direct information about deaths in the war. At NARA, Confederate records are located in Record Group 109, War Dept. Collection of Confederate Records. The records for CMSRs are arranged & indexed by state, have been microfilmed. See microfilm Publication M818 & M253 for additional sources of records. At Arlington Cemetery there is a section for Confederate burials.

Fatal Accident at Ramapo [*Abstract*]. Henry **Johnson**, aged 19 years, son of Stephen **Johnson**, of Ramapo ... was engaged in a piece of woods felling trees ... A tree fell in a direction contrary to that anticipated ... skull fractured ... lingered in an insensible condition until Tuesday when death put an end to his suffering.

The first positive case was that of Timothy **Driscoll**, who was taken on the 22nd of July and died. On last Sunday, the 30th, Timothy **Cronan**, on the hill, was taken and died the next morning. The same night his little daughter, about ten years old was taken, and also his wife, who died on Tuesday. Michael **Sullivan**, the village wood sawyer, was taken down and died on Tuesday. His wife was taken Tuesday evening and died Wednesday morning. William **Splann** was taken on Sunday morning, and died that evening. Daniel **Callahan** was taken on Monday and died at 12 ½ PM on Tuesday. Mrs. **Gorman**, taken at 4 PM on Tuesday and died at 7 AM Wednesday. She leaves four orphan children, one an infant in the cradle. William **Murphy** was taken on Tuesday and died on Wednesday. Up to Wednesday noon eleven deaths had occurred from this cause, and about twelve more under treatment.

Cholera at Haverstraw [Abstract]. There have been several deaths at Haverstraw from this dreadful disease. On Friday evening Michael **Madden** was attacked and died Saturday morning. Mrs. **Kane**, his sister, was taken on Saturday and died on Tuesday. Mary, the daughter of **Madden**, also died on Monday from the same disease. There are other cases whose names we are unable to give.

12 August, 1854

Progress of the Cholera at Piermont. We cannot record the cessation of the scourge, yet there is a reasonable hope it will soon cease. Jacob **Sullivan**, grandchild of Mrs. **Gorman**, mentioned last week, aged between 6 and 7, was taken on the 2nd and died next morning. Mary **Kane**, taken on the 2nd, died on Tuesday. Mrs. James **Murphy** and her child both taken on the 3rd and died within eight hours. Twelve hours later her two month old infant died. Michael **Gorman**, taken on Friday and died on Saturday. Hannah

Sullivan taken on Friday and died on Tuesday the 7th. The wife of Nicholas **Drew** died at half past twelve Sunday. Cornelius **Geary** and his wife both died. Tim **Connell** died at one PM on Wednesday. Mrs. **Murphy** taken Sunday morning and died the same night.

19 August, 1854

Finale of the Cholera at Piermont [Abstract]. We announce that this fearful scourge may be nearly at an end. In our list of deaths last week we should have noted that of Jerry **Sullivan**, age 8. Margaret **Sullivan**, his sister, age 8, died on Monday. A third one of the children was taken on Wednesday night and will probably die. Patrick **Durkin** died on Friday night. We regret to announce the death of Daniel **Styles**. During the pestilence at Piermont, Mr. **Styles** was one of the most active in ministering to the afflicted. We frequently heard his name coupled with acts of kindness.
