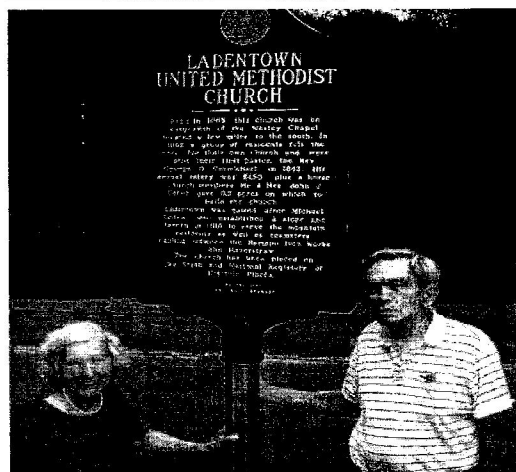

## Ladentown Methodist Church

Methodists in the Ladentown area initially worshipped at the Wesley Chapel. It was considered too far to travel in those days, so the congregation split and they formed the United Methodist Church at Ladentown. The land on which the church was built was donated by John J Secor and his wife.

Joni Anger took on the job of overseeing the restoration of the church inside and out. She was honored the year after the church was put on the National Register, by being presented with the Historic Preservation Merit Award.

The Historical marker was unveiled by Mabel Monks, Bill Swenson, Joni Anger and Marianne Leese, President of the Historical Society of Rockland County. Mabel's great grandfather James Hastings was one of the founders of the church and Trustee for many years. He came to the Ladentown area about 1850. The Hastings Family have been members of the church for generations.

About 50 people turned out for the dedication. They were welcomed by Marianne Leese, and Rev. Raymond Boyd. Pomona Historian, Eloise Litman presented the church history to those in attendance. Mabel talked of growing up in Ladentown and her family attending the church. Bill Swenson has been a member for 70 years. Pomona Deputy Mayor Rita Louie represented the village. She said that Pomona is proud of the church and considers it an asset in the village as she thanked both congregation members and Anger for their decade of rehabilitation.

Sources generally on posted online. Two examples of wrong information passed on to different researchers are: 1) A surname was recorded as "Unk" rather than spelled out for unknown. A cardinal rule of genealogy is "If you don't know, leave it blank."

2) A number of women were listed with a surname of Mnu – in other words: Maiden Name Unknown!

These examples point up a quote from Ronald Reagan: "Trust, But Verify." Don't take for granted any information you may download is accurate, find your own proof.

**Using Wills & Probate Records in Your Research**

by researcher Jackie Feldman:

Probate is a term for the process of administration of the estate of a deceased person supervised by a state court. If there is a will, it is usually brought to the clerk of court in the county where the deceased lived and filed with the court. A petition is made to have the court approve the will and appoint the executor named in the will. If no executor was named, an administrator is appointed. If there is no valid Will, the deceased died intestate and the court appoints an executor to compile the assets, pay any debts and distribute the remaining assets to the heirs and beneficiaries.

Probate minutes are kept by the judge regarding cases heard before a probate court.

A will and/or a probate record will yield clues to heirs, military service, places of birth and clues as to where someone lived in their travels that led to their final destination. Estate sale records may contain information regarding heirs and/or neighbors and good friends and clues to a person's standing in the community.
